

**J&J Fabrics, 413 South Main, Canyonville, OR; (541) 839-4319**

**Going South on I-5**, take Exit 98S (Canyonville/Days Creek), turn left, go 1 block, turn right on Main Street

**Going North on I-5**, take Exit 98N, turn right, go 1 block, turn left on Main St. J&J's is located directly across the street from the Feed Lot Restaurant. (& the "leaning cowboy")

**Thistleberries Old Town Quilt Shop, 336 N Main St, Riddle, OR 97469; (541) 874-3200**

(from J&J's: Go NW on S Main St/OR99 toward SE4th St; W 1st becomes Canyonville-Riddle Rd/CR21; 4.7 mi CR21 becomes Main St.) **Traveling I-5 North** take Exit 103. Turn left. Travel approx 3 mi. crossing bridge. You are on Riddle ByPass Rd. Turn left onto Main St. (sm green Riddle sign on right). Follow into town, cross RR tracks. First building on Right. There is ample parking on the side.

**Traveling I-5 South: Exit 103. Turn right.** Travel approx 3 mi. crossing bridge. You are on Riddle ByPass Rd. (follow above instructions.)

**Country Lady, 611 SE Jackson, Roseburg; (541) 229-1011**

**Driving I-5** from the North or from the South, take Exit 124-City Center Exit. Go East on Harvard. If coming from the North, go through 4 stoplights. If coming from the South, go through 3 stoplights. At the first 4-way stop sign, Jackson Street, turn right; store is on the left hand side.

**Something to Crow About, 4227-C Main Street, Springfield (541) 746-3256**

**Traveling North or South on I-5:** Take Exit 194A traveling East on Hwy 105/126. Take 3<sup>rd</sup> exit, 42<sup>nd</sup> Street, & turn right at the bottom of the ramp. Travel south on 42<sup>nd</sup> Street until you reach Main Street. It is a big intersection with an Arco, Taco Bell, Schucks Auto Parts & McKenzie West Shop'g Center on the corners. Travel through light & turn left into McKenzie West Shopping Center. We are located next to Deb's Restaurant. (Or, turn left at light, get in right lane & turn right into McKenzie Shopping Center.)

**Piece By Piece, Driving I-5 from the north** take exit 194B for I-105/OR 126 W. Take the Jefferson St. exit on the left toward the fairgrounds. Travel straight onto Jefferson St. Turn left on 13<sup>th</sup> Ave. Piece by Piece is on right side of 13<sup>th</sup> Ave between Olive & Willamette Streets. **Driving I-5 from the south** take exit 192 for Franklin Blvd/OR-126-W/OR-99N. Continue traveling west toward Eugene on Franklin Blvd. Make a slight left turn onto E. 11<sup>th</sup> Ave. Turn left onto Olive St. Left onto W. 13<sup>th</sup> Ave. Piece by Piece is on the right side of 13<sup>th</sup> Ave between Olive & Willamette Streets.

**The Quilt Patch, 448 West 3<sup>rd</sup> Ave, Eugene; (541) 484-1925**

**From I-5**, take exit 194B – Continue west on 105/126 crossing the river until hwy turns south. Stay left & turn left (east on 7<sup>th</sup> Avenue (7<sup>th</sup> is one-way street going east). Stay left. Turn left on Lincoln Street. Go north, across railroad tracks. Turn left (east) on 3<sup>rd</sup>. The Quilt Patch is on the left. (Parking in front & across the street). **From the south on Hwy 99**, travel on 6<sup>th</sup> to Washington, (don't go on the off ramp to Valley River – Washington is just after the ramp) turn left on Washington & right on 3<sup>rd</sup> Street. Voila!

**Thimbles & Threads, 665 Ivy Street, Junction City; (541) 998-3312**

**On Hwy 99 north** of Eugene, travel north into Junction City. Thimbles & Threads is in the middle of the block after the second stop light. Turn left into parking lot. If traveling **South on 99**, travel 3-1/2 blocks past the Dairy Queen. Turn right into the parking lot. There is parking in the rear also.

**Callapooya Quilts, 402 Main St, Brownsville, OR 97327; (541) 466-5777**

**From I-5**, take Exit 216, OR 228 toward Halsey/Brownsville; turn left onto OR 228 (becomes W. Bishop Way); turn left on Main St. End at 402 N Main. (Note: the scenic route to or from Corvallis or Junction City, you can take the Halsey/Peoria Rd route to avoid Hwy 34.)

**Quiltwork Patches, 212 SW 3<sup>rd</sup> Corvallis; (541) 752-4820**

**From I-5**, take the Corvallis/Lebanon exit (228). Head west on Hwy 34. Travel approximately 11 miles, cross the Willamette River into Corvallis. Turn left on 4<sup>th</sup>. Go 5 blocks to Jefferson. Turn left, go 1 block to 3<sup>rd</sup>. Turn left. Quiltwork Patches is on the left 3/4 down the block. Note: 3<sup>rd</sup> Street is Hwy 99 going north; 4<sup>th</sup> St. is Hwy 99 going South.

**JanniLou Creations, 1243 Main, Philomath; (541) 929-3795**

**From I-5**, take Hwy 34 (Corvallis) exit #228 & travel west. Follow Hwy 34 approximately 11 miles. Just before crossing the bridge into Corvallis, there is a stop light. Turn left at the light (sign says to the coast) onto Hwy 20/34. Philomath is approximately 5 miles west of Corvallis. JLC is on the north side of Main Street (Highway) between 12<sup>th</sup> & 13<sup>th</sup> Streets. **Note:** Philomath now has a couplet & there is 1-way traffic on portions of Main & Applegate streets. **Be cautious of speed limits!**

**Grandma's Attic Sewing Emporium, 167 SW Court St, Dallas; (503) 623-0451**

**From I-5** take Exit 260 Dallas/Ocean Beaches. Follow along Route 22 across the Marion Street Bridge in Salem. Continue on Route 22 toward the Oregon Coast for about 10-15 minutes. There will be an exit to the left marked Dallas. Drive into Dallas. Turn toward the left when you see the three lanes in Dallas—one goes straight ahead, two turn to the left. You want to turn to the left. Follow this road to downtown Dallas. You will be on Main Street. See the Polk County Courthouse? Get into the right lane. Turn right on Court Street. Travel about 1/2 block. Grandma's Attic will be on the left. **From Hwy 99W** drive north from Junction City, Corvallis & Monmouth. Pass through all these towns. The little town after Monmouth is Rickreall—there's a Fairgrounds to your right just before the town. When you see the Fairgrounds, look for the next traffic light. At that light you turn left toward Dallas. That road will end at Highway 22. Turn left. Drive into Dallas. Turn toward the left when you see the three lanes in Dallas—one goes straight ahead, two turn to the left. You want to turn to the left. Follow this road to downtown Dallas. You will be on Main Street. See the Polk County Courthouse? Get into the right lane. Turn right on Court Street. Travel about 1/2 block & Grandma's Attic will be on the left.
